RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in any event sponsored, promoted, or directed by the local Nelson County Relay for Life Teams, Wheelin' for Hope, the undersigned (for himself or herself, his or her personal representatives, heirs, next of kin, and successors and assigns) **hereby releases**, Nelson County Relay for Life Teams, Woodland Wildfires' members , Trail Experience, Inc., Chris and Carla Boucher, John and Rhonda Holland, and Oak Ridge Estate, their officers, directors, promoters, sponsors, landowners, employees, advertising agencies, affiliates, parent organizations, agents, contractors and subcontractors ("releasees") of all liability to the undersigned, whether caused by the negligent act or omission of releasees or otherwise while the undersigned is for any purpose participating in all the activities involved in such event, including any activities conducted off-site and/or by other entities. It is fully understood by each of the undersigned that there is some inherent risk associated with all the activities involved in this event, including damage to vehicles.

In addition, the undersigned **agrees to indemnify and hold harmless** the releasees from any loss, liability, damage, or cost they incur due to such participation by the undersigned, whether caused by releasees' negligence or otherwise, and **agrees to assume full responsibility and risk** for any bodily injury, death, or property damage from releasees' negligence or otherwise while the undersigned is participating in this event.

If any provision in this Release and Waiver of Liability and Indemnity Agreement is held to be legally invalid, it shall not affect the validity of any other provision.

In signing this release, each of the undersigned hereby acknowledges and represents the following:

1. That he or she has read the foregoing Release and Waiver of Liability and Indemnity Agreement and agrees to its terms.
2. That he or she shall at all times while riding in a vehicle participating in this event wear his or her respective seat and shoulder belts and cause such to be worn by all occupants of his or her vehicle to wear seat and shoulder belts or other federal department of transportation approved restraining devices, including but not limited to those required for children .
3. That the owner/driver has informed himself/herself about the event or trail involved in the event, either by prior participation or by investigation into the event or trail.

ALSO:

I, the undersigned, hereby authorize Nelson County Relay for Life Teams, WHEELIN' for HOPE, its nominees, licensees, advertising and merchandising agencies, and their respective successors and assigns, those acting with its authority and those for whom it is acting (all hereinafter referred to as the "Authorized") to:

1. Use and permit to be used my name, informative material concerning me, and my likeness (either in whole or in part, whether in original or modified form and whether alone or in conjunction with any other material and text matter as the Authorized may determine) for the purposes of advertising, publicizing, and promoting in every manner in all media past, present, and/or future programs and/or activities, without further consideration, except where prohibited by law.
2. Identify my likeness or reproduction thereof in conjunction with any use mentioned above, either by my own name or by a pseudonym or other description.

I agree to waive my right to privacy/publicity. I agree that I shall have no right to inspect or approve any likeness or statement or any exercise of any of the authorizations granted by me hereunder. I agree that any still or motion picture taken of me by those authorized hereunder is owned by them. If I should receive any print, negative, or other copy thereof, I shall not authorize its use by anyone else. I warrant that this authorization does not in any way conflict with any existing commitment on my part. Nothing herein will constitute any obligation by those authorized hereunder to make any use of any of the rights set forth herein.

The term of this authorization shall commence on this date and shall continue for a period of five years thereafter.
